

**NO PURCHASE NECESSARY. PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING ONE ENTRY PER HOUSEHOLD. AGE AND INCOME RESTRICTIONS MAY APPLY.**

- 1. ELIGIBILITY REQUIREMENTS:** The \$1,000 cash drawing Promotion is limited to those person 21 years of age or older. The Truck Key Promotion is limited to those persons who are 30 years of age or older, with a combined household income of at least \$50,000 per year, or those person who are retired. That Entry Blank, once completed, should be mailed as set forth in the enclosure letter that will come with the Entry Blank, starting January 1st through December 20th. The Entry Blank must be received by December 20th. Obtaining the Entry Blank and entering the contest by means of the alternate method will not affect your chances.
